# Compatibility Chart\*

**RootShield® and T22™ HC** are biological fungicides for the control of many root diseases. The active ingredient is a living microbe (*Trichoderma harzianum* strain T-22), which, after application, grows onto plant roots.

Recommendations: RootShield/T22 HC is compatible with the following compounds and can be applied before or after the application of the compound. Even though the a.i. is a fungus, extensive research has shown that RootShield WP and T-22 HC can be tank-mixed with many fungicides (see compatibility table page 2). For incompatible fungicides, BioWorks recommends that RootShield/T22 HC be applied 10 to 14 days before or after chemical fungicide application.
